## 1. Definitions

**Archive Arcana / "we", "us", "our"** — Archive Arcana, the provider of the Service.

**User / "you"** — The individual or entity using the Service.

**Service / Platform** — The Archive Arcana online worldbuilding and TTRPG campaign management platform.

**Realm** — Any fictional setting you create within the Service.

**User Content** — Any content submitted, uploaded, or created by the User within the Service.

## 2. Agreement to Terms

By continuing to access Archive Arcana ("Service," "Platform," "we," "us," or "our"), you ("User," "you," or "your") agree to be bound by these Terms and Conditions. If you do not agree to these terms, you may not access or use the Service except for the purpose of requesting removal of your data.

## 3. Eligibility

You must be at least 16 years old or the age of digital consent in your jurisdiction. If under the age of majority, you may use the Service only with the supervision and consent of a parent or legal guardian.

## 4. Account Registration

You must provide accurate information when creating an account. You are responsible for maintaining the confidentiality of your login credentials and for all actions taken under your account. Notify us immediately of unauthorized use.

## 5. Subscription Plans & Billing

The Service provides free and paid subscription tiers.

### 5.1 Billing Cycles

Subscriptions renew automatically unless cancelled before the renewal date. Fees are charged to your selected payment method.

### 5.2 Changes to Subscription Tier

You may upgrade, downgrade, or cancel your subscription at any time.

- If you downgrade or cancel, access to features and storage above the new tier limits will be restricted.
- We may remove, archive, or limit access to data that exceeds your new plan's limits after **reasonable notice of at least 14 days**.
- You are responsible for exporting your data before removal.
- We will make reasonable efforts to retain essential data, but we do not guarantee preservation.

### 5.3 Refunds

Payments are non-refundable unless required by applicable law.

## 6. User Content & Intellectual Property

### 6.1 Ownership of User Content

You retain full ownership of all User Content. Archive Arcana does not claim ownership over anything you create.

### 6.2 License Granted to Us

To provide the Service, you grant us a limited, worldwide, non-exclusive, revocable license to store, display, transmit, and process your User Content. This license ends when you delete your data, except for:

- backup copies retained for system integrity,
- logs retained for security or legal compliance.

### 6.3 Data protection

We **will never**:

- use User Content to train AI models,
- allow third parties to use User Content for AI training,
- sell, license, or transfer your content for advertising or unrelated commercial purposes.

## 7. Copyright & Content Claims

### 7.1 User Responsibility

You must ensure you have rights to all content you upload.

### 7.2 Takedown on Claim

If we receive a valid copyright complaint or legal request, we may:

- remove the infringing content,
- restrict or suspend the related Realm,
- terminate your account in repeated or severe cases.

### 7.3 Counter-Notice Procedure

If you believe content was removed in error, you may submit a legally valid counter-notice. We may restore the content unless prohibited by law.

## 8. Data Storage & Fair Use

### 8.1 Storage Limits

Each subscription tier includes defined storage and usage limits. If you exceed these limits, we may:

- block new uploads,
- restrict features,
- remove or archive excess data after giving reasonable notice.

### 8.2 Data Retention After Cancellation

After cancellation, your account converts to the free tier. Data above free-tier limits may be removed or become inaccessible after a **minimum 30-day retention period**.

## 9. Changes to the Service

We may modify or discontinue parts of the Service, including pricing or subscription tiers. When feasible, we will provide prior notice of significant changes. Continued use of the Service constitutes acceptance.

## 10. Prohibited Activities

Users may not:

- upload illegal, harmful, or copyrighted material without permission,
- disrupt, attack, or reverse-engineer the Service,
- scrape, mine, or automatically extract data,
- use the platform to harass, threaten, or engage in hate speech,
- impersonate others or misrepresent affiliation.

## 11. Termination

We may suspend or terminate your access:

- for violations of these Terms,
- for repeated copyright infringement,
- for fraudulent or harmful activities,
- where legally required.

You may delete your account at any time. Deleted content may be unrecoverable.

## 12. Disclaimers

The Service is provided **"as is"** without warranties of any kind. We do not guarantee uninterrupted operation, error-free performance, or data permanence.

Some jurisdictions do not allow certain disclaimers, and your rights may vary.

## 13. Limitation of Liability

To the maximum extent allowed by law:

- Archive Arcana is not liable for indirect, consequential, or incidental damages.
- Our total liability for all claims within a 12-month period will not exceed the total amount paid by you during that period.

Nothing in these Terms limits liability for intent, gross negligence, or harm where liability cannot legally be limited.

## 14. Governing Law & Jurisdiction

These Terms are governed by the laws of the **Netherlands**. Disputes will be resolved in the competent courts of the Netherlands unless consumer protection laws in your country require otherwise.

## 15. International Use

Users outside the EU must ensure compliance with their own local laws. By using the Service, you agree that your data may be transferred internationally as described in the Privacy Policy.

## 16. Updates to Terms

We may update these Terms periodically. Major revisions will require renewed acceptance within the Service. Continued use constitutes acceptance of minor updates.
